

# Terms & Conditions

## EVENT CO-OPERATION:

K. Bridals recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed.

## CANCELATION POLICY:

If for any reason, CLIENT cancels their wedding entirely, the following charges of the TOTAL INVOICE AMOUNT will apply.

25% if cancelled one month prior.

50% if cancelled less than one month prior.

The balance payment shall be returned to the client two days after the cancellation, by cheque.

## PRE SHOOT STUDIO MEETING:

We recommend our clients to come in for a pre shoot meeting to discuss their likes, dislikes and preferences. Clients who are interested in a meeting should call us approximately a week before the session and we will schedule a time with them.

## HELICAM:

In certain conditions and venues, helicam cant be operated. Locations where there isnt a GPS signal or if its a no fly zone, Helicam wont work. Even in locations where there are low ceilings, we have difficulty operating a Helicams. If a helicam is booked in that situation, we will not be able to change the package on the last minute .

## DATA DELETION POLICY:

Our video archives are only maintained for six months. It is therefore in your interest to finalize all changes in video before six months from the time it has been shot. Since video takes a lot of space, we cannot archive your video for more than six months.

Our Photography archives are maintained for one year only. After one year, all photography data will be deleted as well. The edited images will be kept for two years.

If you want to purchase any of the data, do so before these dates otherwise we wont be able to provide you with the data.

## THIRD PARTY BOOKING:

Scanned copy of Invoice and Terms & Conditions should be sent to client by the person who is booking for them.

## PERMISSIONS:

When you book with us, you give us the permission to use the images online as our sample work. If you don't want us to use your images, please let us know while booking or via an email.

## LOCATION:

Premier Event coverage by Kashif is only available in Defence, Clifton, Saddar, Shahra-e-Faisal and Karsaz Areas. Transport has to be provided for any areas beyond Airport (e.g Malir and Steel Town).

## COMPLETION SCHEDULE:

Order completion takes two months after selection (excluding time taken by client for approval). It is in your interest to finalise your selection as soon as possible.

## CONTENTS OF FINAL PACKAGE:

You will only be getting what has been mentioned in your invoice. Any additional like all picture CDs, Enlargements etc has to be ordered separately (unless mentioned in your invoice).

## PAYMENT SCHEDULE:

50% deposit is due at time of booking. Balance payable at time of shoot / event date Please note that you will not be booked unless you pay the 50% deposit. Selection CD will only be released on full payment of the agreed amount.

At the time of your booking, you would be given a time-slot for your portrait session. In case of you being late, we would try our best to accommodate you but if there are more bookings on that day, we would have a shortened session or will have to forego it as well. So Please be punctual.
